#### 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

The Education Department, Government of Gujarat started Government Arts and Commerce College in the historical town of Fort-Songadh, District Tapi in June, 2001, situated in the interior of the tribal area.

The college was started with the aim of providing higher education along with Social and Cultural values in the premises of Sarvajanik High School, Songadh.

At present we have 1931 strength of students out of which more than 60% are girl students and more than 95% are ST students. The college started with 221 students in Arts and 19 students in Commerce faculty but at present, in the year 2017-18 the strength of college comprised of 1833 students: 840 Male and 993 Female. The college building has a large premise with separate hostels for boys and girls having a capacity to accommodate 120 boys and 90 girls respectively. There are 16 big rooms which can accommodate 180 students in each one and 8 rooms having a capacity to accommodate 90 students.

There was no institution providing higher education from Vyara to Nizar prior to 2001. With a view to satisfying the basic needs of providing higher education to the students of the most interior area the government started this institution.

At the initial stage the college functioned in the premises of the Sarvajanik High School but the government realised the need of a separate building for college, allocated 1759 lakhs rupees for the construction having a vast campus with all the amenities like hostels, Gymnasium, playground, a staff room with separate table, chair and computer for each department, and library for students.

The institution has proved to be a blessing to the tribal students. It has been the constant efforts of the education department to bring up the students of such an interior tribal area with a view to taking them to the pinnacle of higher education. Our objectives have been to provide education to make their career so that they can compete at the national and international level. Both the academic and non-academic staff is on their toes to make their efforts a success.

#### Vision

The vision of our college is to educate tribal youth and prepare them for the dynamic global competitive scenario while focusing on the computer proficiency, students' communication skills and quality education.

#### Mission

Our mission is to transform the life of the underprivileged, the rural and tribal students through quality higher education and mould them into responsible citizens.

Our efforts have been to bridge the gap of knowledge and skills between the tribal students and urban students, so that they can cope up with the competitive world scenario.

#### 1.3 CRITERIA WISE SUMMARY

#### **Curricular Aspects**

The college is affiliated to Veer Narmad South Gujarat University, Surat and follows the curriculum designed by the university. The college prepares an Academic Calendar that specifies the curriculum to be taught by teachers. It includes duration of the subject to be taught in the classroom, sessions required per unit of the paper, MCQ test, remedial classes, teaching aid, completion syllabus before commencement of internal and external examination. The college receives regular updates through letters and emails regarding circulars, the changes or modifications in the curriculum from the university. The Principal informs the concerned teachers about the change and gives them a copy of the same. —There are two programs, arts and commerce, in which Choice Based Credit System (CBCS) has been implemented. At present there is no Diploma or Add-on programs organized by the institute. The College imparts higher education to all sections of the society irrespective to caste, creed and gender. The college endeavours for holistic develop of the student's personality through various extra-curricular activities including NSS, Sports and cultural programs. The College fulfils its social obligations by conducting various activities throughout the academic years besides learning.

#### **Teaching-learning and Evaluation**

The faculty members are capable of motivating the students enough the whole institute is built to provide education for tribal community of Tapi district. The teachers work with their hearts.

The faculty members tries their best. The teachers also make use of ICT tools make the teaching-learning process interesting. Besides, we have enough library materials and reference books to reach the needs of the students .The library is getting rich day-by-day.

The evaluation process of the institute follows the guidelines of Veer Narmad South Gujarat University, Surat. Internal Evaluation is done by the teachers by considering the punctuality of the students and assignments

provided to them. Whole process of Internal Evaluation is kept transparent for the students.

#### Research, Innovations and Extension

Research is a significant part of teaching learning process. The College supports faculties for research in their subjects. College believes that research increases faculty's insight in the subject and which can be imparted to the students. All the support facilities for research are made available to the researcher like wifi, desktops, and books from library, and support from co-worker.

The College believes in creating a research favorable environment which helps everyone to grow and develop research aptitude.

In the last few years no workshop or seminar could be organized by the college mainly due to lack of sufficient number of staff. However, the faculty members have presented their papers and research papers in regional, national, state level and international level conferences, seminars and workshops.

Many of the direct recruited through GPSC Class 2 permanent faculty members are holding Ph. D. degree and many others are pursuing their Ph. D. degree.

Currently college is providing higher education only to undergraduate students thus scope of research and innovation for students is less but the faculties tries to make them aware about it.

Through extensive activities students are made aware about their responsibilities towards environment, society and subject. International and nation identity days are celebrated with a aim to develop community feeling and imbibe feeling of being a global citizenship.

Research Ethics and research papers of the faculties are uploaded at our website.

#### **Infrastructure and Learning Resources**

The most striking thing about the college is that it covers the area of 15 acres in Fort Songadh of Tapi district. The college has 24 class rooms including 02 seminar room, and open auditorium, a library, huge sports ground, separate parking facility for students and staffroom and ladies room and R.O. plant for mineral water. The whole campus is under surveillance of CCTV camera and has Wi-Fi facility. The college has spacious library with capacity of seating of 80 students. It has a huge play-ground. The institution has parking facility for both the staffs and the students. The college also has a Solar Plant to generate electricity.

#### **Student Support and Progression**

Students are at the core of the institute. Students are at the centre of each activity .The students of this college belong to rural area .Most of them are from tribal communities. The college is pro-active in providing the atmosphere in which their inner strength can be built. Various workshops, programmes are arranged for personality development and career guidance. There are special committees like anti-ragging cell, Grievance redressal cell, SC/ST Cell, Minority Cell etc. The college also makes arrangements for various sports and cultural activities.

#### Governance, Leadership and Management

The college being a government institute is governed by the State Government. The institution has a formal arrangement for the governance. Various techniques are developed for the students' progress under the leadership of principal and all the faculties are encouraged to bring out the best .The administrative management is completely transparent as the college receives grants from the state government and it has to give all the details of the expenditure made. IQAC is formed for internal quality assurance and is managed by the Principal. APIs of all the faculty members are verified and signed by the Principal and are forwarded to the Commissioner of Education. The process is confidential.

#### **Institutional Values and Best Practices**

The institution works with the aim of creating a citizen with high moral and social values with his/her best in curricular and co-curricular aspects. The institution plays a vital role in building a bridge between the students and the society make them visualize their better future. The college arranges blood donation camps, tree -plantation once a year, cleanliness movement (frequently during the year), de-addiction day etc. to bring about changes in the vision of the students towards society. Besides, the college also arranges free coaching classes for competitive exams, skill based programmes like Finishing School, NSDC etc. As the most of the student's economically poor back-grounds, they cannot afford to pay high fees. So the institution tries its best to help them out by providing best faculties and arranging free coaching classes.

#### **Response:**

The College follows the curriculum designed by Veer Narmad South Gujarat University, Surat. At the beginning of every academic year, the college chalks out an academic calendar. The principal of the college sets the time table schedule of each subject for teaching which includes lecture hours.

The head of the departments conducts academic planning meeting to plan and organize the schedule of lectures and distributes the syllabus among the faculty members of their departments. The faculty members are instructed by the head of departments to complete the syllabus within stipulated time. If, for any reason, a faculty fails to finish his/her syllabus within the stipulated time, he/she is being asked to arrange extra classes for his/her subject.

As per the requirement new books are ordered with the concern of subject teachers and students. For implementation of curriculum, teachers have included teaching methods such as presentation, assignments, and seminars for effective teaching. The Board of Studies of Veer Narmad South Gujarat University prepares curriculum of the concern subjects.

The college receives regular updates of circulars through letters and emails from the university, regarding the changes or modifications in the curriculum. The Principal informs the concerned teacher about changes in curriculum and gives them a copy of the same. The faculties receive all sorts of support from the university and college to understand the curriculum. Timely meetings are conducted and instructions are given for submission of Assignments and conducting Unit test and internal test are well planned and executed before final examination.

## 2.2.1 The institution assesses the learning levels of the students, after admission and organises special programs for advanced learners and slow learners

#### **Response:**

Pravesh Utsav is organised for the fresher to welcome them. It is an informative event where the new students are informed regarding the CBCS and semester system along with the rules of the college. The students are aware about the importance of studies along with personality development through co-curricular and extracurricular activities.

The teachers interact with the students in the class and try to judge their level of understanding regarding the subject. Through observations and unit tests teacher tries to identify slow learners and then mentor them to develop their skills. Proper use of ICT is also made for teaching in the classroom which helps students to learn in an effective manner.

Activities like SAPTDHARA, quiz competition, poetry recitation, elocution competition, inter-class competitions etc are organized to develop students potential which gives them confidence to pursue career in such activities.

We have facilities for drinking water (2 R.O.plants of mineral water), fire extinguisher, ladies common room, gymnasium, yoga area, garden, parking, library, clean washrooms for male and female etc. A separate faculty room with proper sitting arrangement is also available.
